CAMBRIA QUEEN, off the pace and off the rail, eased out with a bid leaving the first turn, rounded the final turn four wide and dug in from the head of the lane to take over in late yards. PHONE JAZZ stalked the pace two deep, moved alongside at the three eighths pole, took a slim lead inside the quarter pole, inched clear entering the stretch but was caught in late yards. RUGGED CROSS settled back off the rail, bid from the three eighths pole, eased to the four path at the head of the lane and was just up for show in an even finish. CONGRESIONALAFFAIR rated the pace inside, was challenged from the three eighths pole, dug in to match strides with the runner-up to the quarter pole, yielded to that one through the final turn then weakened in the stretch. MY WILDEST DREAMS settled off the pace about the three path, gave chase from the seven sixteenths pole but flattened stride on the final turn. GLENORIE settled close to the early pace off the rail but lacked further response on the final turn. BACKSTREET AFFAIR was not a factor. CRUISE OVER CLOVER settled close to the early pace inside though faded leaving the first turn.
