PATCH OF FIRE taken in hand to trail for six furlongs, closed willingly three wide and got up in the final strides. CHALICE BEARER had speed from the start while saving ground along the rail through the second turn, angled three wide to make the lead after five furlongs, set the balance of the pace and just missed hanging on. TOOTHACHE vied for the lead four wide from the start, drew on near even terms for the lead at the half mile pole, remained a sharp threat into the stretch then weakened late. HASTA LA PASTA pressed the pace three wide for a half then weakened. LAVIN'S BLUFF was no factor. VIOLET CIRCLE away alertly, set the pace for five furlongs then gradually gave way. FILLYPINO had brief speed. COBBLEYS JINGLE offered little.
