Footnotes

MICKEYTHEPREACHER made the lead four wide down the backstretch, drew off around the turn, prevailed while kept to urging. JUDGE MARSHALL shuffled back on the rail along the backstretch, rallied four wide on the turn to be second best. SOUTHERN FOLLY reluctant to load, pressed the pace three wide, lacked a late bid. BOLD LITTLE MAN stalked the leaders four and five wide, lacked the needed rally. EIGHT GOLD MEDALS off a step slow then in tight at the start, passed tired ones three wide. LEON'S WAY within striking distance three wide, failed to respond. THE FENIAN WARRIOR set the early pace, fell back after a half. CANDY FOR NICO well placed on the rail, had no rally. JUST A DEL SUR was no factor from the inside and was easing through the stretch. Due to a timer malfunction, splits and final time were hand timed.
