Footnotes

HEY THERE on the rail setting the pace, bore out late on the turn, drop down in the upper stretch, lugged out late stretch while clear. CLARKE COUNTY three and four wide rallying, checked late on the turn when the winner came out then lacked a closing bid. BEST TO GO WEST stalked the leaders from the inside, bid three wide around the turn, lacked a late response. SOUTHERN WILL pressed the issue just off the rail, lacked the needed rally. WON MY AFFAIR bumped at the start, passed tiring rivals four wide. CHARMING SAWYER within striking distance along the inside, failed to respond when asked in the lane. LUCKY TEN saved ground, rallied along the rail on the turn, failed to sustain his bid. GREEN RECRUIT broke awkwardly to the outside and bumped with WON MY AFFAIR at the start, was no factor three and four wide. LUXURY TAX prompted the pace three and four wide, came six wide into the stretch while tiring. There was an objection by the rider of CLARKE COUNTY against the winner and a Stewards inquiry involving the run around the turn. After a review of the video tape replays HEY THERE was disqualified from first and placed second.
