ROYAL ZONE set the pace on the rail, held a clear lead into the stretch but was all out to last. ALL THE GLORY pressed the issue outside the winner, finished strongly. VAN GOAL prompted the pace three wide, lacked a late response. ESPIRITO saved ground, rallied around the turn and finished willingly. MAJOR MAX off the pace three wide, lacked the needed late rally. MR. ETHAN made a run four wide along the backstretch, flattened out. NATURES TIME flashed brief foot on the rail. EMOCAO made little impact, three and four wide.
