Footnotes

PICK UP THE TAB quickly moved up to press the issue outside BIG RED RIVER then in a long drive, was all out to last. BIG RED RIVER bore out at the start impeding several rivals, angled back down to set the pace, was joined by the winner around the turn then missed in a strong effort. WILD CAPTAIN BOB checked at the start, saved ground, rallied three wide on the turn but had no late bid. VISION WITHINREACH forced the issue four wide, lacked a late response. SUMTHIN STRAIT soundly bumped at the start, stalked the leaders from the inside while no threat. SNEAKING SUSPICION bumped sideways at the start, was no factor three wide. CHEROKEE MUSCLE kept seven wide, failed to menace. The rider of WILD CAPTAIN BOB lodged a claim of foul against the winner alleging interference at the start. The Stewards reviewed the video tape replays and disqualified BID RED RIVER from second and placed him third.
