LIL BRIGHT BERRY dueled on a slim lead down the backstretch, drew off around the turn, widened through the stretch under steady urging. FUZZYWUZZYWUZABEAR stalked the leaders from the inside, bid four wide on the turn, was bumped and checked in late stretch finishing on even terms with MO MO TOBIN at the end. MO MO TOBIN broke awkwardly and steadied at the start, advanced five wide to become a factor around the turn, closed strongly through the lane but lugged in late stretch, bumped with FUZZYWUZZYWUZABEAR while no threat to the winner. LOADS OF FUN prompted the issue just off the rail, lacked a late response. EL PISTON never threatened along the inside. NO MORE JEALOUSY forced the pace three wide, lacked the needed rally. LOUD RAVENS showed little, three and four wide. E. T. WONDER pressed the issue from the rail, tired. The rider of FUZZYWUZZYWUZABEAR claimed foul against MO MO TOBIN for interference in late stretch. Following a review of the video tape replays the Stewards disqualified MO MO TOBIN from the dead heat for second and placed him third dissolving the dead heat.
