PRETTY GIRL SHERRY pressed the pace just off the rail, gained a slim lead then lugged out some through the stretch, held clear under a strong drive. GOLDEN NINER angled down early, tightened up several foes, alternated on the lead from the rail and was second best. SEMINOLE GALE exchanged bumps shortly after the start while on the rail, eased out three wide around the turn, lacked a late bid. GINGER BEAR three wide down the backstretch, rallied along the rail on the turn but failed to sustain her bid. SHE'S MY MYSTERY bumped and then in tight shortly after the start, was with the pace three and four wide, lacked a closing bid. ALI P SLICK showed early speed four wide, lacked the needed rally. WILD CHARM never was a factor, four wide. BASHA'S DANCER bumped and squeezed back shortly after the start, trailed throughout. The rider of SHE'S MY MYSTERY lodged a claim of foul against the rider of GOLDEN NINER alleging interference shortly after the start. The Stewards reviewed the video tape replays and disqualified GOLDEN NINER from second and placed her last.
