Footnotes

BURNT OFFERING, quickly in command, rated the pace inside, was pressured from the three eighths pole, driven into the lane and steadily handled to hold well. RASCAL CAT rated off the pace inside, bid nearing the three eighths pole, kept close aim on the final turn but was turned back in the stretch drive. SILVER SLUGGER settled off the early pace off the rail, eased to the five path with a bid toward the seven sixteenths pole and raced evenly from there. M'S WILL rounded the opening turn about the four path, settled close outside into the backstretch, bid at the five sixteenths pole then had little further in the stretch. TYLER'S JEWEL, well back off the rail, eased outward on the final turn, entered the stretch widest and could only improve his position. GUSKA'S GOLD rated close to the early pace four wide, took aim nearing the seven sixteenths pole, raced evenly down the backstretch but weakened on the final turn. GREEN RECRUIT raced well back toward mid track. MIA'S ANGEL rated close to the early pace two deep, picked up the chase nearing the three eighths pole, faded toward the quarter pole, showed no further response on the final turn and was eased in the lane.
