THE THIRD RUNNING OF THE LADY CHARLES TOWN. Fillies Three Years Old. Free nominations, \$250 to enter. Nominations close Wednesday, June 9, 2010. Purse will be \$100,000 guaranteed. After payment of 1% to all owners of horses finishing 7th through last, 60% of the remaining purse shall be paid to the owner of winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth and 2% to sixth. Supplemental nominations of \$5,000 due at time of entry, all fees included. Weight: 121 lbs. Non-winners of \$22,000 in 2010 allowed 3 lbs., a race other than maiden or claiming in 2010 allowed 6 lbs. Field will be limited to ten starters with four on the alternates list. Preference to stakes winners in order (Grade I, Grade II, Grade III), then stakes winners, then highest lifetime earnings. Starters to be named through the entry box by the usual time of closing. Trophy to owner of winner.

DOWN TOWN ALLEN was hustled along to make the lead shortly after entering the main track, set the balance of the pace and drew off under a brisk hand ride. VERONICA'S LAKE advanced quickly along the rail soon after the start, steadied repeatedly while lacking racing room, angled out four wide on the turn then rallied determinedly and finished clear for second. SOUTHERN TRUTH never far back while hung five wide, had a mild late rally. STARRING SKY chased the winner along the rail into the stretch then weakened the final sixteenth. KINSOLVING offered a mild bid along the rail on the turn then came up empty. KENNY LANE had brief speed five wide. HIGH FIVE GAL failed to menace. MILC KIDS was outrun. ENTRANCED was hustled from the start, flashed speed and gradually gave way. GRAEMY trailed.
