**Footnotes**

BELLE OF CAMDEN moved to the inside to rate a short lead two deep, was pressured past the three eighths pole, contested a slight advantage through the turn and dug in under a determined drive to edge clear toward the wire. DI COLAS GIRL settled off the early pace inside, started a bid leaving the five sixteenths pole, eased to the outside of the faltering Can't Run A Jump midstretch and dueled that one for place. CAN'T RUN A JUMP rated with the pace inside, challenged the winner toward the quarter pole, dueled to a slim brief lead just inside the eighth pole but leveled off toward the wire. BROAD BUT NICE stalked the pace about the three path, gave chase from the three eighths pole, loomed a close factor three wide on the final turn but leveled off down the lane. RAPID VICTORY settled back off the rail, bid leaving the half mile pole then leveled out in the stretch. TURNING LYPH broke a step slow and was not a factor. SISTER JANE was not a factor.
