LORI Z'S PUNCH pressed the pace two wide, took command in midstretch and forged ahead under a drive. KELA'S PRIDE chased the pace from the rail, got through in upper stretch, vied inside, bumped with SOUTHERN SQUALL late and narrowly outfinished that foe for the place. SOUTHERN SQUALL bumped with HEAVEN'S VOICE just after the start, rushed up inside to set the pace along the rail, was collared near the sixteenth pole, bumped with KELA'S PRIDE and steadied nearing the wire. HEAVEN'S VOICE bumped with SOUTHERN SQUALL just after the start, raced along the rail and rallied mildly. STORMY PASS chased the pace four wide and faded around the turn. FLATTERING ANNIE was outrun while racing three wide. The rider of SOUTHERN SQUALL claimed foul against KELA'S PRIDE for alleged interference in the stretch but the Stewards found no reason to alter the original order of finish.
