BEAUTY WITHIN chased the pace from the three path, dueled to the lead toward midstretch, drifted outward the final sixteenth but dug in to last. MISS RUBY T chased the early pace about the four path, came in getting her heels clipped nearing the quarter pole, angled six wide into the lane then back inside the drifting winner midstretch but was outfinished to the wire. I M UNBOOBOOBABLE chased the pace from the inside and held aim to deep stretch before leveling off. CHIGOE drew clear to set the pace inside, came under pressure in mid turn, yielded control midstretch and leveled off from there. A. P. RACETTE chased the early pace toward the outside, saved ground approaching the turn but proved empty in the stretch. CRIBBING SAMMI, well back inside, mildly improved off the rail rounding the turn. COUNTRY WARNING, reluctant to load, chased the early pace outside, rounded the turn five wide and weakened in the stretch. SAMMYS RAISIN chased the pace off the rail, was shut off clipping the heels of Miss Ruby T approaching the quarter pole and gave way from there. POCKETFUL OF FAME was reluctant to load and no factor. CRYSTAL D was only briefly close before fading on the backstretch. The stewards reviewed two claims of foul. The first claim against the runner-up, lodged by the rider of unplaced Sammys Raisin, was allowed and Miss Ruby T was disqualified from second and placed eighth for coming across the path of Sammy's Raisin, causing that one to check and clip heels approaching the quarter pole. The second claim of foul was against the winning rider, lodged by the rider of the runner-up, but dismissed.
