Footnotes

DESERT DAYLIGHT chased the pace three wide, assumed a slim lead nearing the eighth pole, drew clear beyond there and held well with steady handling. FOLLOW THE WHALES chased the pace toward mid track, came through the turn five wide and closed to deep stretch before leveling off. GOLDEN SWIRL bobbled at the start, settled into stride off the rail on the backstretch, made up ground through the turn, eased out at the top of the stretch and was closing well late. WHO NELLIE chased the pace two deep while between horses, dropped back into the turn then flattened stride in the lane. VIRGINIA WEST, fractious in the gate, was hustled clear for position inside nearing the seven sixteenths pole, contested the rail on the turn though weakened past the eighth. GRACIE CAT chased the early pace inside then lacked sufficient response on the turn. DANGEROUS MIND steadied early and showed no speed outside. SPAGHETTI WESTERN was outrun. NATALIES BUCKAROO bobbled at the break and was outrun. LADY'S BOPETTE was outrun.
