Footnotes

IN ANY CASE bumped entering the first turn while three wide, grabbed the lead from MISS KANIPTION on the backstretch, dug in when challenged by SOUTH COUNTY LADY approaching the stretch, drifted out and brushed repeatedly with that rival in the stretch drive, dug in gamely to earn a narrow decision. SOUTH COUNTY LADY never far back, made a menacing move on the second turn, brushed repeatedly with IN ANY CASE through the final furlong, just missed. WHITFIELD VALAY went four wide on the first turn, worked her way to a good position nearing the stretch, weakened. DIXIE IN RAGTIME bumped with MISS INTIMIDATOR at the start, was well placed passing the three furlong marker, tired. GOOD BIT settled in the second flight early, failed to respond. TOAST TO MIKE bumped at the start, asked for speed, exchanged bumps with IN ANY CASE entering the clubhouse turn, stayed close to pace for four furlongs then gave way. MISS KANIPTION offered little resistance when challenged by IN ANY CASE for the lead after setting the pace for a half mile, dropped from contention through the far turn. NO PRESS BABY was slow early, showed little. MANOR SPRINGS put in a dull effort. MISS INTIMADATOR bumped on both sides at the start, trailed throughout.
