Footnotes

SEEUONOTHERADIO set the pace along the rail and drew off under a drive. STAND UP STAN prompted the pace two wide, could not keep pace with the winner around the far turn, continued on his left lead in the lane and held second. HOWARD COUNTY stalked the pace two wide between foes around the first turn, dropped back two wide around the far turn and held the show. SLEWS ROYAL GOLD chased the pace inside and weakened three deep around the far turn. TUMULTUOUS saved ground early, went four wide around the far turn and never threatened. IMY'S BOY hit the rail early, failed to menace and returned bleeding around the left stifle. PAINTED OCEAN was outrun inside. DANCING HEART had brief speed three wide. INCLUDE'S AMBITION never factored while racing two and three wide.
