SOUTHERN SQUALL set the pace along the rail, inherited a clear lead when SPUNKETTE bore out near the quarter pole and widened under a drive the in the lane. PELT THE FLANK was carried eight wide near the quarter pole, stayed well out there most of the turn and was up for the place. ELUSIVE APPEAL saved ground and bested the rest. BRIGHTEST CRYSTAL chased the pace two wide and tired in the lane. HASTA LA PASTA was outrun while racing four wide. BANCO BANNER was never a factor while racing three wide. SPUNKETTE pressed the pace two wide, bore out entering the turn, was pulled up, appeared sore and walked off. SUBIRA broke down. &nbsp;The Stewards conducted an inquiry into the incidents around the turn and found no reason to alter the original order of finish.
