DI COLAS GIRL pressed the pace three wide, gained the lead on the turn, held clear through the stretch under a drive. AIKEN VACATION advanced three and four wide, finished well. SIZZLING HOT moved up four and five wide, finished strongly. RHYTHM N RED saved ground, rallied four wide on the turn, failed to sustain her bid. JESSICA WABBIT five wide throughout, finished willingly. MEETMISSPATTICAKES set the pace on the rail, remained a factor around the turn, weakened in the drive. FOLLOW THE STAR within striking distance on the rail, failed to respond. MY FIRST KISS a pace factor three and four wide, lacked a late response. XORDINARY PROSPECT hopped at the start then was no factor.
