**Footnotes**

VERO BEACH was hustled to the front to rate a slim lead inside, drove off through the turn and under steady stretch handling to widen slightly. DAVINA'S BABY came away sharply to a clear though brief lead on the chute, rated close to the winner two deep on the backstretch, gave chase through the final turn and finished evenly while not a match for the winner. NICKNMINA chased the early pace toward the inside, came out to make contact with Devora just inside the eighth pole and finished evenly. DEVORA chased the pace about the three path, was bumped out past the eighth pole and leveled off in the stretch. SUCCULENT SCORE came away awkwardly, chased the pace toward mid track, saved ground into the turn, entered the stretch three wide and leveled off. SUREHOPESO chased the early pace from the outside but showed no response while four wide on the turn. GAIL'S ROYAL FLUSH chased the pace off the rail but steadied toward the quarter pole. THISCOULDBETRICKY lacked speed while outside early then saved ground through the turn. JET TIDE chased the pace toward mid track, was pinched back nearing the turn then bore out from the quarter pole and no further factor. The stewards reviewed a claim of foul against the rider of the third place finisher, lodged by the rider of the fourth place finisher but took no action.
