Footnotes

SHAMSS stalked the leaders from the rail, rallied inside around the far turn, split horses approaching the stretch, exchanged bumps with THREE STEPPER in upper stretch, seized command near the sixteenth pole and pulled away late under steady left handed urging. THREE STEPPER chased the pace just off the rail, rallied two to three wide around the far turn, exchanged bumps with the winner in upper stretch, reached even terms in mid stretch then was out kicked in the final sixteenth. LEOBUSTER was hustled to the lead, set the pace along the rail, quickly drew clear, remained clear to upper stretch, lost the advantage in mid stretch, weakened through the final sixteenth. MADMAN pressed the pace from the rail, gave way around the far turn. FIRST KING unhurried early while racing three wide, continued three wide around the far turn, lacked a closing bid. UTMOST RESPECT saved ground early, raced four wide around the far turn, failed to menace. WOODLAND was never a factor inside. The rider of THREE STEPPER claimed foul against SHAMSS, alleging interference around the far turn and in upper stretch. After a review of the video tape replays, the Stewards found no reason for disqualification.
