POW WOW POWER four wide down the backstretch, dropped to the inside on the turn, drew off through the stretch under a drive. JUDGE MARSHALL pressed the pace just off the rail, gained a slim lead in the upper stretch but was out finished. GET ER DONE GEORGE moved up three wide, lacked a closing bid. APPEALING CAMERON set the pace on the rail, checked into last turn and fell back. MAKE A WESH failed to menace, three wide. BECOME MY HERO passed tiring rivals along the rail. P. T. DANCER a pace factor four and five wide, lacked a late response. THEEDGEOFTHERIVER was used up after a half on the rail. JUST DAVID showed little, four wide. RUN WITHA ATTITUDE stopped after a half along the inside. The rider of APPEALING CAMERON claimed foul against JUDGE MARSHALL alleging interference into the turn. The Stewards reviewed the video tape replays but allowed the original order of finish to stand.
