WALKING ON AIR forced the pace three wide, gained a slim lead in the upper stretch but was all out to last. MR. SKAGGS pressed the pace just off the rail, had aim into the stretch but hung in the drive. JUDGE MARSHALL bore out and steadied at the start, rallied three wide around the turn then made a mild gain through the stretch. DUSTIN MILLIE off a step slow, moved up the rail, lacked a closing bid. WHATDIDISAY stalked the leaders four and five wide, failed to respond. BLACK TIE DEPUTY was forced out and steadied at the start, was with the pace four wide, fell back on the turn. MAKIN A RUN set the pace for a half, gave way around the turn. GO GIZMO showed early speed, had little left after a half. QUOITS LEGEND never was a factor, five wide. MAKIN MOOLA showed little, inside.
