**Footnotes**

WICKED GRACIE , three wide both turns, disputed the pace, gained a clear advantage entering the stretch, lugged in near the sixteenth pole and was kept to urging to prevail. THOUGHTWUZABOY stalked the duel, eased out four wide entering the stretch and rallied. FAST AND FRIENDLY saved ground, dueled to midstretch and weakened. BREADMAN'S HONEY , two wide between horses, disputed the pace to the far turn then weakened through the stretch. CIVIL DANCER circled the far turn and failed to rally. GARNER FAVOR , lightly steadied in close quarters along the rail near the five sixteenths pole, was not a factor. SKEETER'S JO ELLE weakened. ZELBELLE was not a factor. SIOUXPERLOVEY , in tight quarters leaving the starting gate, raced four wide the first turn, three wide the far turn and was outrun. JALO MY HALO dropped far back.
