LORD PARKER circled the turn, was four wide entering the stretch, closed determinedly and was along in time. DOTS RECORD SHOP brushed with MR ROBB leaving the starting gate, set the pace along the rail, opened up entering the stretch and weakened late. ROBB'S HOLME chased the pace three wide in a willing effort. DANCING VALIANT raced slightly off the rail, was blocked approaching the stretch, eased out and closed the gap late. LEON'S WAY brushed with DOTS RECORD SHOP leaving the starting gate, saved ground and had a slight rally. MILLWOOD chased the pace two wide and gave way late. CLOSER TO PEACE , two wide between horses on the turn, failed to rally. MR ROBB circled the turn in the three path and failed to be a factor. HOTEL SIERRA , wide on the turn, gave way. WICKLIFFE MAN circled the turn and trailed.
