Non-winners of a stakes race in 2007, allowed 3 lbs.; \$12,000 twice in 2007, 5 lbs.; \$12,000 once in 2007, 7 lbs. (Maiden or claiming races not considered in estimating weight allowances.) Preference to ten starters with highest career earnings. Trophy to the winning owner. Field limited to ten starters, with four on the also eligible. Starters named through the entry box by the usual time of closing.

HOMESTEADER set the pace on the rail, dug in around the turn but was out finished. UNLAWFUL SPIRIT prompted the leaders along the rail, lacked a late response. CASSE failed to menace, inside.
