WILD PROOF set the pace along the rail, quickly drew clear, drifted four wide into the lane and held clear under a drive. JAZZ SEEKER was unhurried while racing three wide around the first turn, advanced a bit down the backstretch, continued to gain slightly while three wide around the far turn then finished willingly to be clearly second best. FOR APPEAL lacked speed while racing three wide through the opening half, moved up three wide between rivals around the far turn and was along for third. ROEN'S STAR stalked the pace from the rail, made a mild advance along the inside around the far turn and came up empty in the lane. I'M NOT A BABY stalked the pace two wide through the opening half-mile and faded around the far turn. PARADO was devoid of speed while racing along the rail early then improved his position four wide around the far turn. BOBBY AND BOB never factored while racing two wide. JENKIN JONES was unhurried while racing three wide early, advanced four wide nearing the quarter pole, was eased leaving the three-sixteenths pole and vanned off after the finish.
