**Footnotes**

C V'S DEVELEN settled back inside the opening quarter, started his advance past the half mile pole, took the lead inside nearing the final turn then dug in through the lane to hold on well. LAST TRIBUTE stumbled from the gate, came through the first turn five wide, took the lead past the half mile pole, chased the winner nearing the quarter and remained a close factor to the wire. RUSH W, wide the opening turn, closed outside on the backstretch, saved ground the final turn then leveled off in the lane. CONTINUOUS MINER, three wide the opening turn, rated off the pace on the backstretch, was pressured toward the final turn then faded while saving ground. TIGER APPEAL set the early pace inside, stalked the leader past the nine sixteenths pole, ran three wide on the backstretch then faded through the final turn. I ROCK was outrun. SHINY BLUE, off the pace outside, showed no response on the final turn. COTTON HEARTED stalked the pace from the inside though faded after a half mile.
