Footnotes

COOPER COUNTY settled close to the early pace inside, bid approaching the quarter pole, angled out at the top of the lane and continued a steady advance to get up the final stride. JOYFUL KISS was hustled for early control to save ground, rated the pace through the backstretch, came under pressure into the final turn, drew clear at the top of the lane but was caught the final stride. ADRIANA'S BOY steadied at the heels of Joyful Kiss into the first turn, stalked the pace two deep down the backstretch, took aim nearing the quarter pole, raced a close factor through the final turn, lost some ground entering the lane but came back to finish well between horses. ROCK N' BID showed no early speed about the four path, made a mild advance inside through the backstretch but leveled off in the lane. HALFWAY HOUSE, five wide the opening turn, showed no speed inside down the backstretch then had no rally. FOR APPEAL was outrun while saving ground. THEWAYOFTHE SAMURAI, off the pace about the four path, faded rounding the final turn. WATCHTHISKICK kept close to the early pace about the three path then weakened losing ground on the final turn. The stewards reviewed a claim of foul against the rider of Joyful Kiss, lodged by the rider of Adriana's Boy, and disqualified the former for coming across the path of the latter entering the first turn.
