Footnotes

VIVO was unhurried while saving ground through the opening half-mile, cruised up two wide around the far turn to take the lead in upper stretch, continued on his left lead in the lane and quickly drew off while drifting out a bit under right-handed urging. TODAY AND ALWAYS stalked the pace from the rail, took command inside of foes nearing the five-sixteenths pole, briefly went clear leaving the quarter pole but could not match strides with the winner in upper stretch. CLARKE COUNTY stalked the pace three and four wide, came up empty around the far turn and continued on his left lead in the lane. KINGPOST failed to menace while racing four and five wide. PREVENGE set the pace in the two path and tired around the far turn. FORTY WINKS was no factor while racing five and six wide.
