ICE FIGHTER set the pace two wide, cleared and angled to the rail down the backstretch, was collared by TAZMAN GREEN near the quarter pole, pressed that foe inside around the far turn and battled back under left-handed urging to regain command in deep stretch and prevail in a game effort. TAZMAN GREEN stalked the pace three wide around the first turn, took command two deep near the quarter pole, led two wide around the far turn and hung in the lane. TINSMAN raced three wide around both turns and was along for the show. SIR PRIZE led early along the rail, was trying to get out entering the first turn, steadied off heels near the nine-sixteenths pole and faded inside. TEMPLEWOOD was no factor while racing three and four wide. TIME IS NOW was outrun while racing two and three wide. SUPREME NOTION had brief speed inside. BLACK 'N TAN was crowded at the start and and outrun while racing two and three wide.
