APPEALING SISTER exchanged light contact with Navy Dame leaving the gate, ran six wide the opening turn, briefly settled back outside, closed toward contention through the backstretch, moved alongside the pacesetter past the three sixteenths pole, dug in from the top of the stretch for a slim lead inside the sixteenth pole and inched clear under the wire. VIA AURELIA rated off the early pace inside, was boxed in past the three eighths pole, eased around the tiring pacesetter toward the quarter pole, entered the stretch three wide and was just up for place in an even finish. GRAY STORM A'COMIN stalked the pace off the rail, had a slim lead near the five sixteenths pole, dueled with the advantage to the sixteenth pole then reluctantly ceded the closing yards. INDY TECH, off the pace off the rail, made a mild outside bid on the final turn and ran evenly through the lane. KITTIAHAWK stalked the pace about the four path, had aim to the middle of the final turn, eased five wide into the stretch and weakened from there. PARASIZASTIFF, outrun, passed tired rivals outside. NAVY DAME exchanged light contact with Appealing Sister leaving the gate, ran five wide the first turn and was outrun. LADY MCBRAVE rated a clear lead inside, was threatened inside the three eighths pole and faded readily. DREAMIN TO REALITY and PECAN TASSIE were not factors.
