Footnotes

ALLEGHENY JACK was unprepared for the start, rushed up five wide to establish a stalking position, went three wide around the second turn, advanced two wide around the far turn, struck the front in midstretch and prevailed in a game effort. TERMSOFENGAGEMENT lagged toward the inside early, went five wide around the clubhouse turn, advanced four wide around the far turn, closed outside and just missed. OCASTA set a clear pace off the rail, weakened nearing the lane and was collared near the sixteenth pole. SUPREME RULER tracked the pace three and four wide and lacked the needed rally. WILD AND WILEY failed to menace while racing four and five wide. TIP OF THE SWORD lagged inside, raced five wide around the far turn and passed tiring rivals. MAXIMOSO stalked the pace inside and tired around the far turn. PROUD OF MIDWAY was outrun inside. LITTLE FEAT chased inside and retreated after three-quarters. FINAL STRAW was outrun while racing three wide.
