Footnotes

MS BOP stalked the pace three wide through the backstretch, held aim rounding the turn, dueled for control midstretch and was steadily encouraged to draw clear. CHATEAUNEUF DU BOP was bumped inward and into Icy And Civil leaving the gate, chased the pace three wide on the backstretch, lost ground through the turn, entered the lane about the five path and was closing well late; Brandon Whitacre lost his whip just under the wire to no affect. NO PARACHUTE, hustled to the front along the rail, raced evenly to the middle of the turn, came under pressure from that point, was caught midstretch and leveled off. PEPTO PANTSER broke inward, gave chase two deep then leveled off in the lane. ICY AND CIVIL broke in to exchange contact with Thera Lyn, was pinched back a stride later, gave chase toward mid track, entered the stretch six wide but proved empty in the drive. BRADSHAW RUN, slow into stride, gave chase from well back inside, eased out rounding the turn, entered the lane in the four path and had little further. SITTING O NITRO chased the pace from the inside and had nothing left in the stretch. THERA LYN lunged outward to exchange contact with Icy And Civil at the break, pulled up sore post race and was vanned off. WATCH AND WONDER chased the early pace from the inside, lost momentum at the heels of Pepto Pantser at the five sixteenths pole and weakened. OMAMORI NINJA was not a factor. The stewards reviewed a claim of foul against the second and fourth place finishers, lodged by the rider of the fifth place finisher and disqualified the fourth place finisher for causing a chain reaction which resulted in the fifth place finisher being pinched back at the start.
