WHAT TIME rated a slim lead two deep to the five sixteenths pole, moved clear into the final turn and dug in under a steady left hand drive to maintain. SOFIASHUTCHBUSTER rated back three wide, closed ground toward the final turn, moved to the winners poll past the three sixteenths pole but lagged a length through the stretch. MR. TOMCAT settled back inside, bid mildly off the rail on the final turn, entered the stretch three wide though leveled off from there. UNBRUSH, awkward at the break, rated back about the three path, advanced his position into the final turn, steadied at the heels of the waning Mala Mala Cat past the three sixteenths pole, angled four wide into the lane and finished evenly. SWINGING SCOOTER was shuffled back after the start, showed no speed outside, bid widest on the final turn then passed some tiring rivals. NEW YORK MOON rated off the pace about the three path, started a bid toward the final turn but had no further response through the turn. PRAIRIE BOY was through after a half mile. MALA MALA CAT, briefly clear into the first turn, stayed with the pace to the five sixteenths pole then faded through the final turn.
