RIVER ANGEL pressed the pace three wide, took over in midstretch and just withstood a late challenge from the runner-up. ALWAYSACONTEST settled off the pace while racing two wide, angled out in upper stretch, closed outside and just missed. SWEET CONTENT chased the pace three wide and finished well to gain the show in the final strides. BELINDA'S BEAUTY set the pace in the two path, continued on her left lead in the lane, was collared in midstretch and weakened. COCO COBANA failed to menace while racing four wide. SURRENDERTHEMONEY forced the pace from the rail, continued on her left lead in the lane and tired. MERRY LYNN stumbled at the start, raced four and five wide and never threatened. QUEST FOR CANDY was not a factor while racing four wide. HIGH RESOLVE trailed well off the rail.
