DEVONSPAINTEDLADY lacked speed, moved up on the final turn, swung wide in upper stretch, closed and drove clear. BELLE OF CAMDEN chased the pace in the two path around the final turn and finished willingly. DI COLAS GIRL , three wide the first two turns, gained the lead on the backstretch, opened a clear advantage on the final bend and tired in the drive. SECRET DAB saved ground the final turn, swung out near the sixteenth pole and failed to sustain her bid. MALIBU KITTEN raced well off the rail and weakened. CASTINA , three wide the first turn, dropped back leaving the backstretch. PRINTSCESS POACH set a slow pace along the rail, gave way on the backstretch then was eased.
