RAMBLIN GYPSY pressed the pace just off the rail, made the lead down the backstretch, held clear thereafter while kept to a drive. MELEIUM stalked the pace four wide, finished well. NORDIC LASS jostled at the start, was five wide throughout and closed willingly. CAPE ELIZABETH taken out three wide late on the backstretch, was with the pace but came up empty in the drive. A LOOSE KISSER in tight at the start, was no threat three wide. LADY VERONICA saved ground to no avail. AIME MOI TOUJOUR within striking distance three wide, lacked the needed rally. SEATTLE APPEAL well placed three wide, lacked a closing bid. FATIMA'S PRINCESS set the pace along the rail, gave way down the backstretch. GOLD N FANCY showed little four wide.
