Footnotes

CHLOE'S KO PRIDE set the pace under heavy pressure, slowly drew clear. STORM JUMPER prompted the issue three wide, bid around the turn, hung in the drive. SAINT ANTHONY bore out and bumped with THE SHINNING STONE at the start, forced the pace four and five wide then finished well. PLEAD MY CASE broke in a tangle and was bumped, moved up four and five wide, finished willingly. CRUSADER'S STRIKE within striking distance three wide, lacked a late response. NICOLE'S PROSPECT up close along the inside, lacked a closing bid. THE SHINNING STONE sluggish at the start the bumped, tried to stay close on the rail, lacked the needed late rally. SGT. BART off a step slow, was well placed three wide, failed to respond. RENIER six wide throughout, lacked a late bid. GREATBELLS OF FIRE flashed brief foot on the rail.
