REBEL'S WALTZ advance four wide, gained the lead nearing the sixteenth pole then drove clear. JUDGE MARSHALL prompted the pace three wide, had aim in the upper stretch, hung in the drive. PINEAPPLE PETE saved ground, rallied three wide on the turn, finished well. COREY'S COURT forced the issue along the rail, lacked a late response. NIKAM set the pace under heavy pressure, weakened in the drive. DR. BARCH tardy at the start, was within striking distance four and five wide, lacked a closing bid. PUNK ROBINSON pressed the issue just off the rail, lacked a late bid. MAKIN DOON failed to menace, three wide. SHECKATOO sluggish at the start, showed little. MR. SKAGGS stopped after a half, three and four wide.
