FIGPENN prompted the pace two wide, took over leaving the seven-sixteenths marker, set the pace in the two path from there, dug in when confronted by LUCA'S WIND DANCER in upper stretch and prevailed in a game effort. LUCA'S WIND DANCER settled off the pace along the rail, advanced between rivals down the backstretch, gave close chase two wide around the far turn, angled in to bid inside of the winner turning for home, vied inside of that foe in tight quarters through the lane and just missed. CLEAR REASON settled off the pace while racing three wide, advanced three wide around the far turn, to loom boldly near the three-sixteenths pole then flattened out in the lane. TIZ FRIDAY stalked the pace two and three wide and came up empty. AIKEN VACATION failed to menace while racing inside. ROBB'S WARRIOR set the pace along the rail and tired around the far turn. FINAL STRAW was outrun inside. R. J. SAYS was outrun while racing two and three wide.
