Footnotes

TREAT TO SUCCESS settled back toward mid track, bid nearing the three eighths pole, took over approaching the quarter pole, opened up rounding the final turn and held well under steady stretch encouragement. I'M TOO FAST, well off the pace toward mid track, bid leaving the seven sixteenths pole, rounded the final turn about the three path and had to settle for second. SMOKE ON THE RIDGE rated off the pace inside, started a drive at the rail leaving the half mile pole, angled outward midway on the final turn then lugged inward while leveling off down the lane. SLAVIC AURA, well back off the rail, angled out at the half mile pole, bid from the three eighths, had her heels clipped racing in the five path midway on the final turn then leveled off down the lane. ALL BIZ moved to the front two deep nearing the three quarter pole, saved ground past the five eighths, rated clear through the backstretch, was pressured nearing the quarter pole but weakened rounding the final turn. HOT MAY FIRE rated off the pace off the rail, started a bid near the three eighths pole, was forced outward midway on the final turn then leveled off down the lane. RECKLESS MAMA had a slim lead inside, gave chase off the rail leaving the half mile pole then faded nearing the final turn. YELLOWSTONE LAKE, off the pace in the three and four paths, picked up the chase from the three eighths pole, was never a factor then fell over a fallen rival midway on the final turn but was walked off post race. TOMAHAWK TALK, off the pace inside, eased out past the quarter pole, steadied off the heels of Hot May Fire past the quarter pole, clipped the heels of Slavic Aura at that point and fell though walked off post race. A stewards inquiry and subsequent claim of foul, lodged by the rider of Hot May Fire, against the rider of Smoke On The Ridge, resulted in the disqualification of the latter, to last place, for causing the chain reaction which resulted in the incident midway on the final turn.
