I FOUND SWEETIEPIE angled into the two path nearing the first turn, pushing ANNKATHRIN in in front of DE ALIBI, raced three wide around the first turn, inched closer down the backstretch, rallied three wide around the far turn, took command near the sixteenth pole and prevailed under left-handed urging. FARNELL'S ALLEY set the pace along the rail, led to midstretch and held well to preserve the place. GORDANA settled off the pace near the inside, advanced four wide around the far turn and finished well to gain the show. PEACE ON EARTH settled off the pace in the two path early, advanced three wide down the backstretch, bid nearing the lane then flattened out in the drive. IMADEVLISHDIVA pressed the pace three wide and weakened in the lane. DE ALIBI checked off heels nearing the first turn, saved ground around that bend, advanced three wide around the far turn and rallied mildly. CAMDEN'S DREAM saved ground and failed to menace. SABINE TULLIE saved ground to no avail. ANNKATHRIN hesitated at the start and was outrun inside. LOVE ME OVER pressed the pace two wide between foes and faltered nearing the far turn. Following a stewards inquiry and an objection of from the rider of DE ALIBI, I FOUND SWEETIEPIE was disqualified from first and placed sixth.
