DIXIE HEAT up close early from the outside, advanced up the backstretch, reached a striking position entering the second turn, gained command and was well clear while kept to task. MY GIRL JULES well placed from between foes, advanced entering the second turn, responded and was gaining late. DEVONSPAINTEDLADY chased the early pace from the outside, steadily advanced up the backstretch, responded and finished well. DI COLAS GIRL dueled from the outside for the early lead, remained engaged up the backstretch, held a forward position entering the drive but tired late. PRINTSCESS POACH dueled from the inside but tired in the drive. C B ROCKS could only pass tired ones. SILVER CUB chased the early pace from the inside but had nothing left. MALIBU KITTEN flashed early speed and tired. I GOT A ANSWER was never close. VIVICAT was outrun.
