**Footnotes**

SON OF A BEAR prompted the pace while racing three wide early, advanced outside down the backstretch, continued to gain while racing in the two path around the far turn, brushed with SHOWMETHETRICK in upper stretch, battled head to head with that rival past the sixteenth pole then spurred clear in deep stretch. SHOWMETHETRICK pressed the pace just off the rail around the first turn, took the lead at the half-mile pole, angled to the rail entering the far turn, brushed with SON OF A BEAR in upper stretch, dueled inside of that rival past the sixteenth pole then gave way in deep stretch. I GOT A ANSWER forced the pace from the rail, moved up inside down the backstretch, could not match strides with the top two in upper stretch but continued willingly inside through the lane. LIFE ON THE RIVER was unhurried while racing three wide around the first turn, angled toward the rail down the backstretch, moved up inside around the far turn then finished evenly through the lane. LOUD RAVENS raced in mid pack while two to three wide around the first turn, advanced outside down the backstretch, raced three wide around the far turn, lacked a late response. ROBB TRADD set a pressured pace along the rail, lost the advantage at the half-mile pole then steadily retreated. WARLOCKED was never a factor. RUTLEDGE LION raced extremely wide around the first turn then never got involved.
