RUNAWAY BRAE tracked the pace three wide, made steady progress down the backstretch, moved to the front midway around the far turn and drew off under a drive. BELLE OF CAMDEN set the pace along the rail, was collared near the three-sixteenths pole and held well enough to preserve the place. SECRETARYOFDEFENSE saved ground early, advanced three wide around the far turn and was along for the show. SMART REPAIR lacked speed inside, raced four wide around the far turn and passed tiring rivals. SING UR HEART OUT raced three wide and was not a factor. DI COLAS GIRL stalked the pace inside and tired after a half. GLENORIE stalked the pace two wide and was used up after a half. PRINTSCESS POACH saved ground, retreated down the backstretch and was eased.
