**Footnotes**

AUTUMN AFFAIR was hustled up for lead, angled in approaching the first turn and herded WARRIOR WALTZ into HOT SAUCE, the latter of which came out immediately after to avoid hitting the rail, causing a chain reaction in which HOT SAUCE, WARRIOR WALTZ, KISS PRINTS and IDEAL THOUGHTS were bumped and forced wide, set a clear pace toward the inside and widened under a drive in the lane. HOT SAUCE bumped with IDEAL THOUGHTS when that rival broke outwardly, had speed along the rail, was bounced around entering the first turn, stalked the pace two wide thereafter and was unable to reel in the winner while drifting in a bit in the stretch. LIL MISS JANE settled off the pace along the rail, avoided the incident into the first turn, moved up inside around the far turn, angled out nearing the sixteenth pole and finished evenly. MY GIRL JULES lacked speed, was steadied and taken very wide when several rivals bumped and altered out ahead her entering the first turn, was kept six wide throughout and passed tiring rivals. IDEAL THOUGHTS broke outwardly and awkwardly and bumped with HOT SAUCE soon after the start, angled four wide nearing the first turn, was soundly bumped and forced to steady nearing the five-eighths pole, raced five and four wide throughout and lacked a serious response. WARRIOR WALTZ was forced into HOT SAUCE when AUTUMN AFFAIR angled in nearing the first turn, was bumped out into KISS PRINTS immediately after as HOT SAUCE came off the rail, stalked the pace three wide and came up empty. KISS PRINTS was bumped and forced to check and alter out entering the first turn, had brief speed four wide and tired. Following claims of foul by the riders of HOT SAUCE and WARRIOR WALTZ for interference entering the first turn, AUTUMN AFFAIR was disqualified and placed last. Claims of foul by the rider of IDEAL THOUGHTS against HOT SAUCE for alleged interference at the start and from the rider of LIL MISS JANE against HOT SAUCE for alleged interference in the stretch were not allowed.
