MISTER QUALITY set the pace under heavy pressure then in a long drive, was all out to last. FOREST DREAM pressed the pace three wide and also in a long drive, missed in a strong effort. SALEM'S CAT prompted the pace three and four wide, lacked a late response. SANDYBAY BOOTLEGER stalked the pace four wide, failed to respond. PLEADING GUILTY forced the pace inside, lacked a closing bid. QUIET APPEAL never threatened inside. HESA FORTUNE PRO failed to menace four wide. BLUE MON showed little three wide. STRANGE WAYZ BABY trailed three wide.
