LADY PARROT was five wide down the backstretch, came four wide on the turn, gained the lead and drew off late. PLUNGE AHEAD set the pace inside but out finished in the stretch. MISS SAMOS rallied inside on the turn, lacked a late response. PHALAROPE was hustled along down the backstretch, came six wide on the turn but failed to respond when asked in the drive. FLYING DOVE CAFE was seven wide turn making a bid but was no threat in the drive. PAMELA'S TRIAL pressed the pace three wide, gave way in the stretch. SONG REQUEST had speed for a quarter and, stopped.
