Supplemental nominations of \$2,000 due at time of entry, all fees included. Weights: Three Year Olds, 121, lbs.; Older, 124 lbs. Non winners of a Sweepstakes in 2008, allowed, 3 lbs., non-winners of \$22,000 since July 1, allowed, 5 lbs., non-winners of a race other than maiden or claiming since June 1, allowed, 7 lbs. Field will be limited to ten starters with four on the also-eligible list. Preference to stakes winners, then highest earnings in 2008. Starters to be named through the entry box by the usual time of closing. Trophy to the owner of the winner.

TAINT SO forced the early pace from the outside, remained forward entering the drive but had nothing left. P. KERNEY dueled from the inside early and tired. DONALD'S PRIDE could only pass tired ones. ARE YOU SERIOUS was no factor. COOPER COUNTY dueled from the inside and gave way. FOREST PARK was finished early.
