Footnotes

MIA'S ANGEL stalked the pace two deep while between horses leaving the half mile pole, took the lead approaching the quarter pole, drifted out from mid turn, entered the stretch about the five path but dug in from there and held on. CRACK THEPAT settled off the pace about the four path, started a bid leaving the five sixteenths pole, was carried to the seven path into the lane, dug in widest from there to get place late yards and gaining slowly on the winner. TYLER'S JEWEL, well back off the rail, advanced from the three eighths pole, closed to the heels of Nic's Amigo near the quarter pole, lost momentum through the final turn, eased four wide with a bid into the lane then outfinished for place. DEANOGUSKA settled back inside, bid nearing the quarter pole, rounded the turn about the four path then leveled out late stretch. GUSKA'S GOLD stalked the pace three wide, moved to challenge past the half mile pole, gave chase toward the final turn, had aim while losing ground entering the stretch but leveled off from the sixteenth pole. NIC'S AMIGO was kept close to the early pace inside but lacked further response approaching the final turn. HEY THERE rounded the opening turn in the four and five paths, settled off the pace outside then weakened saving ground on the final turn. THUNDER OF LOVE, reluctant to load, never factored. READ MY TALE was not a factor racing outside. KELA'S ASSAULT maintained a short lead inside the opening half mile, was caught leaving the five sixteenths pole and gave chase to the quarter before fading.
